4. All minutes of Governing Body should be submitted to office of Aryabhatta Knowledge University, Patna at the earliest.
5. When any vacant post will be filled by the college/institute, University representative should be invited. Any appointments must be done in presence of University representative.
6. College is requested to submit the residential address proof, Adhar card along with mobile number of all teaching & non teaching employee.
7. Provisional affiliation has been granted in anticipation of approval of the Court, Aryabhatta Knowledge University, Patna.
8. Provisional affiliation shall not take effect unless it is approved by the State Government.
